



damages are inadequate to remedy the injury, monetary damages are difficult to compute, and the injury involves a breach of fiduciary duty;

2. Unless this restraint is ordered immediately, without notice to Defendant, Plaintiff will suffer irreparable injury immediately, because no other legal remedy can be obtained and effected before the injury occurs;

3. Plaintiff has no adequate remedy at law;

4. Plaintiff has exercised due diligence in prosecuting the underlying claim in this cause;

5. Plaintiff's injury will outweigh any injury to Defendant that may occur on issuance of this restraining order;

6. the restraining order will not disserve the public interest;

7. the *status quo* should be maintained, in the public interest; and

8. Plaintiff's bond in the amount of \$ 500.00 <sup>JMC</sup> will fully protect Defendant's rights until a hearing can be held on Plaintiff's application for a temporary injunction.

It is therefore ORDERED that a temporary restraining order issue, operative until the date of the hearing hereinafter ordered, restraining and enjoining defendant from Defendants, provided that, before the issuance of the restraining order, Plaintiff must post bond in the amount of \$ 500.00 <sup>JMC</sup>, payable to Defendant, conditioned and approved as required by law.

It is ORDERED that the temporary restraining order shall enjoin Defendants "from conducting any vote effecting an election or a change to the bylaws or articles of incorporation of the Texas VHF-FM Society, Inc. unless voting is conducted by mail."
